

# PRIVACY STATEMENT

Duraflex, Inc. recognizes the importance of protecting your personal information and is committed to safeguarding your privacy online. **1. COLLECTION OF PERSONAL INFORMATION.** When you engage in certain activities on this site, Duraflex, Inc. may ask you to provide certain information about yourself by filling out and submitting an online form. **3. LOG FILES.** As is true of most Web sites, Duraflex, Inc. gathers certain information automatically and stores it in log files. This information includes internet protocol (IP) addresses, browser type, internet service provider (ISP), referring/exit pages, operating system, date/time stamp, and clickstream data.

Duraflex, Inc. uses this information, which does not identify individual users, to analyze trends, to administer the site, to track users' movements around the site and to gather demographic information about our user base as a whole.
